### **Scheduling**

- Contact Amanda Bryda to schedule a flu clinic at your worksite. Scheduling will begin July 9, 2018 on a first come first serve basis.
- 2. We average about 25 shots per hour and will schedule time accordingly based on the number of employees expected to attend.
- 3. We will require 7 days' notice if you wish to have other vaccinations offered at your clinic.
- 4. We will schedule clinics for one continuous time period per day. Please keep this in mind in regard to shift changes etc.
- 5. We suggest a Human Resources Representative from your company be present throughout the clinic to help answer questions and encourage eligible participants to receive a shot.
- 6. All forms should be filled out correctly and in their entirety (Big Y will email forms in advance so that your employees have a chance to fill them out prior to the start of the clinic).
- All employees are required to bring their Insurance Card or a photo copy of their card.
- 8. We request 72 hours' notice if a cancellation needs to take place.

- 2. An automatic 15 shots will be billed by Big Y to your company after the clinic date if the 20 person minimum is not reached.
- 3. Each company will be billed and held responsible for payment for any shots given to employees that are <u>not</u> (fully/partially) covered by insurance or prefer to pay cash. Cash price is \$30 per quadrivalent vaccine and \$60 per high dose vaccine.
- 4. Cash pricing will vary for other vaccinations. Inquire for more information.
